3.	Conflicts/Attendance Each Pre-Pro Co./PPC, member will be allotted 7 approved conflicts for the entire 2024/2025 season (August 2024 – May 2025). An approved conflict is defined as a conflict that is communicated to and approved by the Company Manager/Administrator no less than 48 hours prior. Conflicts that do not meet these standards will be classified as an unapproved conflict. Unapproved conflicts, exceeding the number of allotted approved conflicts, or repeated tardiness will result in a conversation with the company Artistic Director. By signing this agreement, you acknowledge this policy, and agree to mandatory rehearsal and performance dates for the 2024/2025 season and agree to abide by the stated conflict policy. Inability to attend any added rehearsals/dates will not count against your allotted conflicts. However, if you agree to attend an added date and later rescind your acceptance of that date, it will be counted towards your allotted conflicts.
